


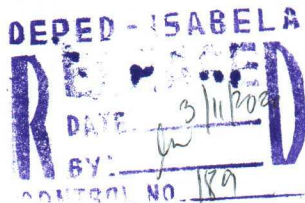

Subject: **UPDATING OF SCHOOL AND DISTRICT LEARNING RESOURCE
QUALITY ASSURANCE TEAMS (LRQAT)**

1. The Curriculum Implementation Division through the Learning Management Section would like to inform the field on the Updating of School and District Learning Resource Quality Assurance Team (LRQAT).
2. Quality Assurance as a sub system of the LRMDs would include evaluating locally developed materials for shared distribution via the LR Portal. To uphold standards of quality learning materials which are designed for uploading and publishing in the LR Portal, these materials pass through the hands and scrutiny of the Learning Resource Quality Assurance Teams of the School, District, Division and Regional Level.
3. To ensure the quality of teacher developed learning materials, there is a need to organize the Learning Resource Quality Assurance Team (LRQAT) per level of governance (*Enclosure No. 1*).
4. Anent to this, schools and districts are required to organize the LRQAT not later than April 3, 2020 and furnish a copy of the names of the members of the team with their roles by sending it to maria.lastra@deped.gov.ph.
